PARKING AND TRAFFIC TICKET DISPUTE SERVICES

Let Easy Works book a court date to fight your parking ticket/infraction

If you have ever tried to fight a parking or traffic ticket, you know just how frustrating and time-consuming it can be. Unfortunately, many people reluctantly opt to pay the ticket fine rather than go through the official process of requesting a trial. In doing so, they waive their fundamental right to fight the ticket. In the case of a speeding ticket, the decision you make could have long term financial consequences, through increased insurance rates and demerit points.

With Easy Works, fighting parking and traffic tickets in the City of Toronto has never been easier. Simply enter your infraction # and ticket type, and provide us with some necessary vehicle and payment information. We will attend the Municipal Law Enforcement Office and/or Court office, choose option 3 on your ticket and formally request a trial date on your behalf.

Here's the simple process you follow:

- 1) Visit our services page and click on "Parking Ticket Services"
 - 2) Click on "Fight your ticket"
 - 3) Enter your infraction #, ticket type and vehicle registration information as specified on the web page
 - 4) After submitting your details, please arrange to make your payment within two business days. Our rates are \$9 for parking tickets and \$19 for traffic tickets. We accept payment via Interac Email Money Transfer*, and PayPal**. All electronic payments should be sent to payments@easyworks.ca
 - 5) Ticket dispute requests will only be processed after we have received your payment in full. If we do not receive your payment within two business days, your request will automatically be canceled and you will have to resubmit your ticket information on our web site
 - 6) After your payment is received in full, you'll receive a confirmation # and receipt within one business day
 - 7) Easy Works will handle all the paperwork on your behalf, including the NOTICE OF INTENTION TO APPEAR at Court for a trial
 - 8) If you have submitted a parking ticket dispute, Easy Works will formally attend the Municipal Law Enforcement Office and submit notice of your request for a trial to Parking Tag Operations
 - 9) If you have submitted a traffic ticket dispute, Easy Works will formally attend the Court office and submit notice of your request for a trial to the Clerk's office
 - 10) Within seven business days after your payment is received, you'll receive an email confirming that your information was successfully submitted to Parking Tag Operations and/or the Clerk's office
- Our service concludes after this step. We do not provide legal representation at your trial. If you receive a notice for a court date, you are responsible for it.**
- 11) You'll receive a written notice from the courts advising you of your trial date. This notice is usually sent after a couple of months. Expect delays, however, as traffic court is extremely backlogged and cases could be delayed for up to a year and a half. Minor tickets very rarely proceed to a full trial. Often, \$30 and \$40 dollar tickets will end up canceled.

* To send an Interac Email Money Transfer, you need to have access to online banking at a participating financial institution (BMO Bank of Montreal, CIBC, RBC Royal Bank, Scotiabank, TD Canada Trust, or select credit union). When you send an Interac Email Money Transfer, the sender must also enter a security question along with the answer. The recipient must provide the correct answer to the sender's security question in order for the email money transfer to be successful. Easy Works kindly requests that you either email us your security question & answer (information can be sent to payments@easyworks.ca) or call us at 647-282-5345 and be ready to provide our staff with this information so that we can finalize your transaction and process your ticket dispute request.
